Cavan Ventures Inc. enters into Investor Relations Agreement with MarketSmart Communications Inc.

Cavan Ventures Inc. (the “Company”) is pleased to announce that it has entered into an investor relations agreement with MarketSmart Communications Inc. (“MarketSmart”) for a period of six months. MarketSmart is a Vancouver-based investor relations firm and their services for the Company will include initiating an investor awareness program that will introduce the Company to MarketSmart’s network of brokers, private investors, portfolio managers and media contacts, providing shareholder and investor communication services, handling the Company’s public and media relations, and any other services as agreed upon by the Company and MarketSmart. The Company will pay MarketSmart \$5000 per month and issue options to purchase 200,000 shares of the Company at \$0.15 cents per share. One-quarter of the options granted shall vest on the four month anniversary of the agreement, and the right to exercise an additional one-quarter of the options shall vest every four months thereafter. The agreement may be cancelled by either party within 30 days written notice. This agreement remains subject to regulatory approval, including that of the TSX Venture Exchange.
